**OFFICE OF FOREIGN ASSETS CONTROL  
REPORT OF LICENSING ACTIVITIES  
PURSUANT TO  
THE TRADE SANCTIONS REFORM AND EXPORT ENHANCEMENT ACT OF 2000**

**July - Sept 2018**

This report is submitted pursuant to Section 906(b) of the Trade Sanctions Reform and Export Enhancement Act of 2000 (TSRA) and covers activities undertaken by the Department of the Treasury's Office of Foreign Assets Control (OFAC) under Section 906(a)(1) of the TSRA from July through September 2018. Under the procedures established in its TSRA-related regulations, OFAC processes license applications requesting authorization to export agricultural commodities, medicine, and medical devices to Iran and Sudan<sup>1</sup> under the licensing regime set forth in Section 906 of the TSRA.

From July 1 through September 30, 2018, OFAC's Licensing Division received a total of 72 applications pursuant to Section 906(a)(1) of the TSRA. During this period, OFAC issued a total of 71 licensing determinations,<sup>2</sup> of which 56 were for cases received in this quarter. OFAC issued 12 licenses, 1 license amendment, 16 "return-without-action" letters, 0 denial letters, and 38 general license guidance letters<sup>3</sup> in this quarter. Of the total licenses issued, 12 involved products for Iran and 0 for Sudan. For more details, see Charts 1-3 and Graph 1.

<sup>1</sup>Pursuant to Section 906 of the TSRA, an OFAC license is still required for certain exports and reexports to Sudan as a result of Sudan's inclusion on the State Sponsors of Terrorism List. Effective October 12, 2017, OFAC issued and made available on its website General License A authorizing exports and reexports pursuant to the TSRA to Sudan. With the lifting of the Sudan Sanctions, General License A has been incorporated into the Terrorism List Government Sanctions Regulations, 31 CFR part 596, as new section 596.506 effective June 29, 2018.

<sup>2</sup>A "licensing determination" is any action that OFAC takes on a license application. It may take the form of a license, a license amendment, a "return-without-action" letter, a general information letter, a general license guidance letter, an interpretive letter, a denial letter, or a close-out determination.

<sup>3</sup>In addition to the licensing determinations reflected in Charts 1-3 and Graph 1, in this period OFAC issued 38 general license guidance letters in response to pending license applications, with an average processing time of 21 business days. These general license guidance letters provide information about certain general licenses that OFAC has issued, consistent with Section 906(a)(1) of the TSRA, authorizing certain exports of agricultural commodities, medicine, and medical devices to Iran and Sudan.
