GENERAL LICENSE NO. 26A

**Transactions Authorized Pursuant to the
Russian Harmful Foreign Activities Sanctions Regulations**

(a) Except as provided in paragraph (b) of this general license, all transactions prohibited by Executive Order (E.O.) 13662 involving one or more blocked persons listed in the Annex to this general license, or any entity in which those blocked persons own, directly or indirectly, individually or in the aggregate, a 50 percent or greater interest, that are authorized or exempt under the Russian Harmful Foreign Activities Sanctions Regulations, 31 CFR part 587 (RuHSR), including transactions authorized by a general or specific license, are authorized.

(b) This general license does not authorize:

(1) Any transaction prohibited by a directive issued pursuant to E.O. 13662, as incorporated into sections 589.202 through 589.205 of the Ukraine-/Russia-Related Sanctions Regulations, 31 CFR part 589 (URSR); or

(2) Any transaction involving any person blocked pursuant to the RuHSR or the URSR, other than the blocked persons described in paragraph (a) of this general license, unless separately authorized.

(c) Effective January 15, 2025, General License No. 26, dated January 10, 2025, is replaced and superseded in its entirety by this General License No. 26A.
